

Annotations for Evidence

Before you learn whether you will work for the prosecution or the defense, read the following passages from "Rikki-Tikki-Tavi." Then, after each one, write R if this evidence helps Rikki-Tikki's case, or S if it helps the snakes'. Explain each answer in a single sentence.

When reading the passage, consider the character's "motive", and how the selection would make the jury feel if it were read out loud in court.

Motive- (n)- a criminal's reason for breaking the law Eg) Auguste's motive for quitting the theatre was stress.

What was Rikki's motive for killing? What was the snakes'? Keep these questions in mind as you read.
